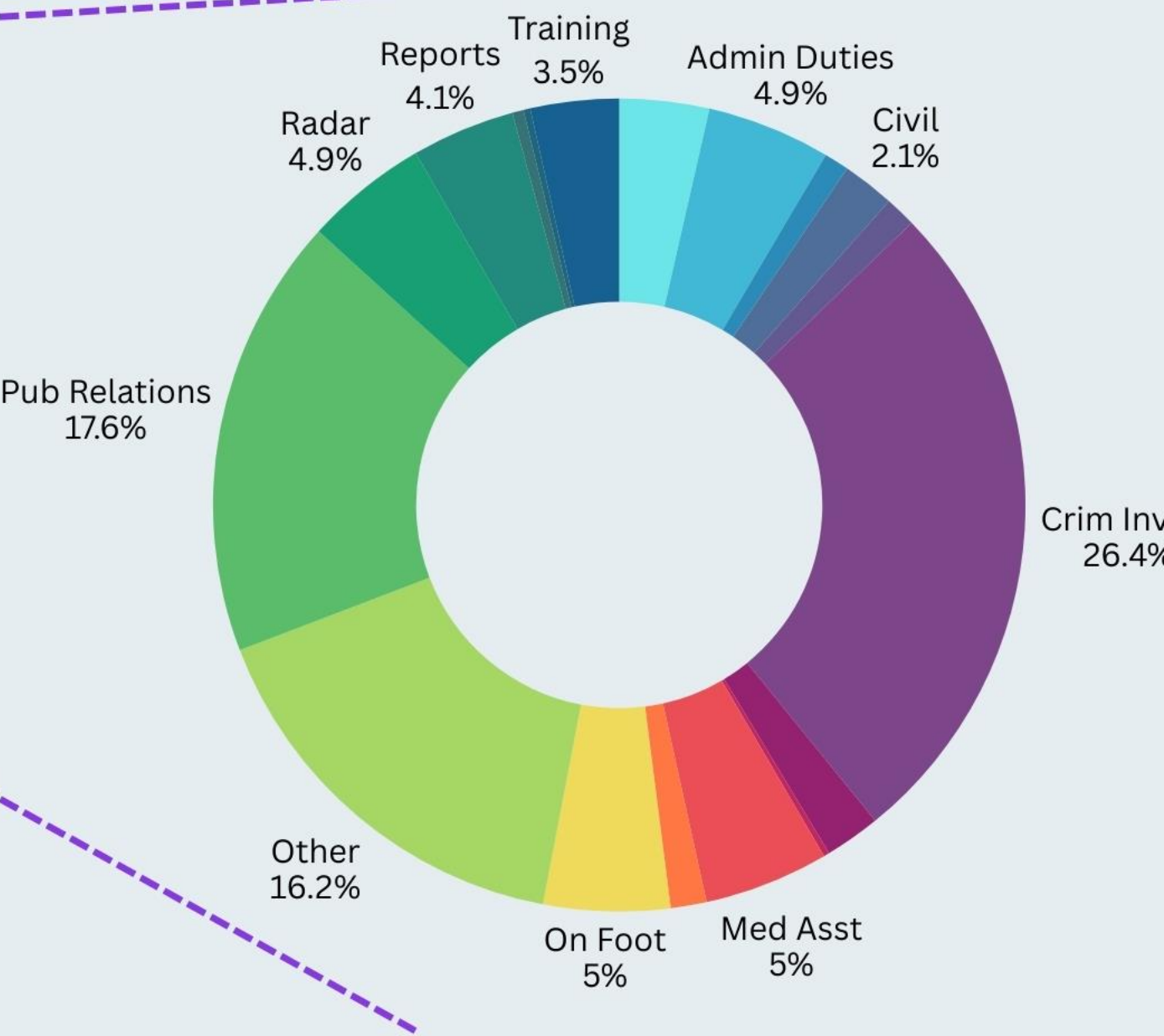
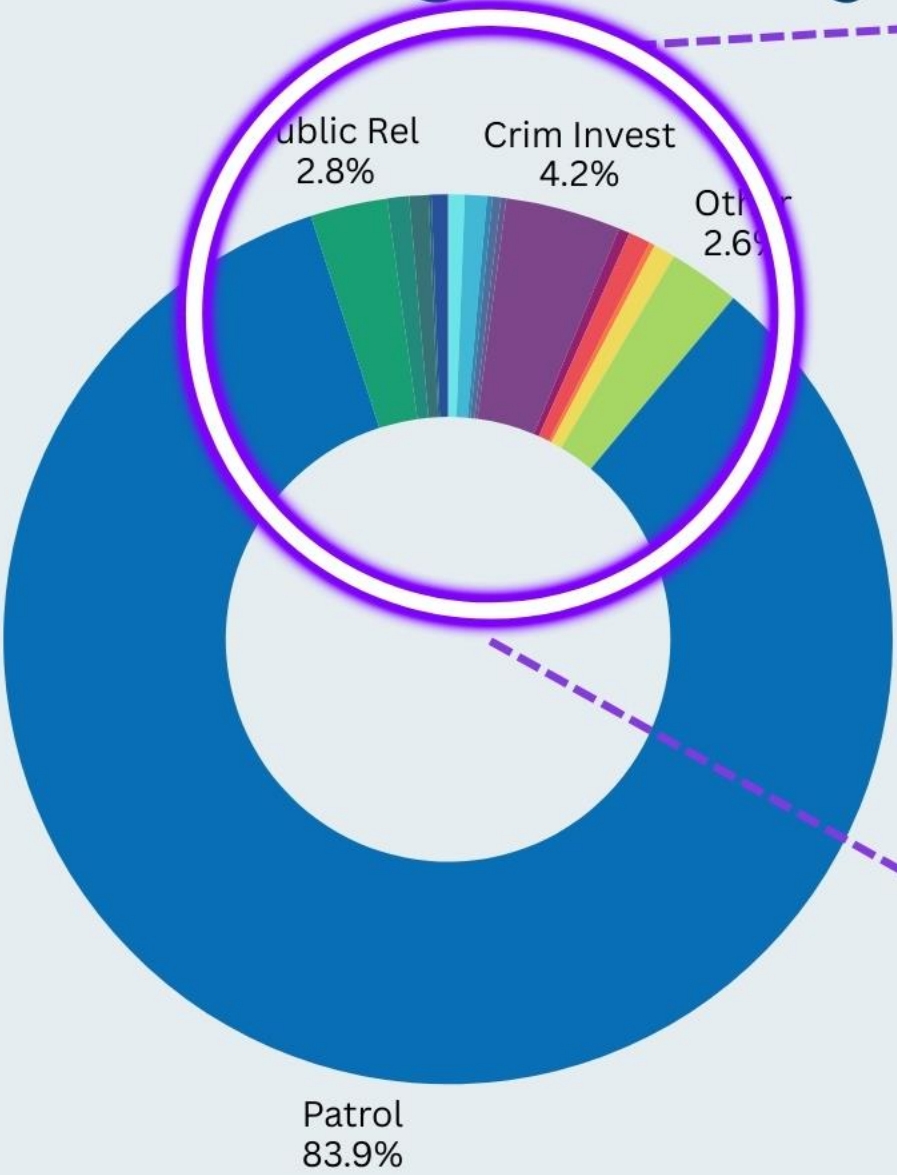
# Patrol Log Activity 23-24, **Hours Over/Under**



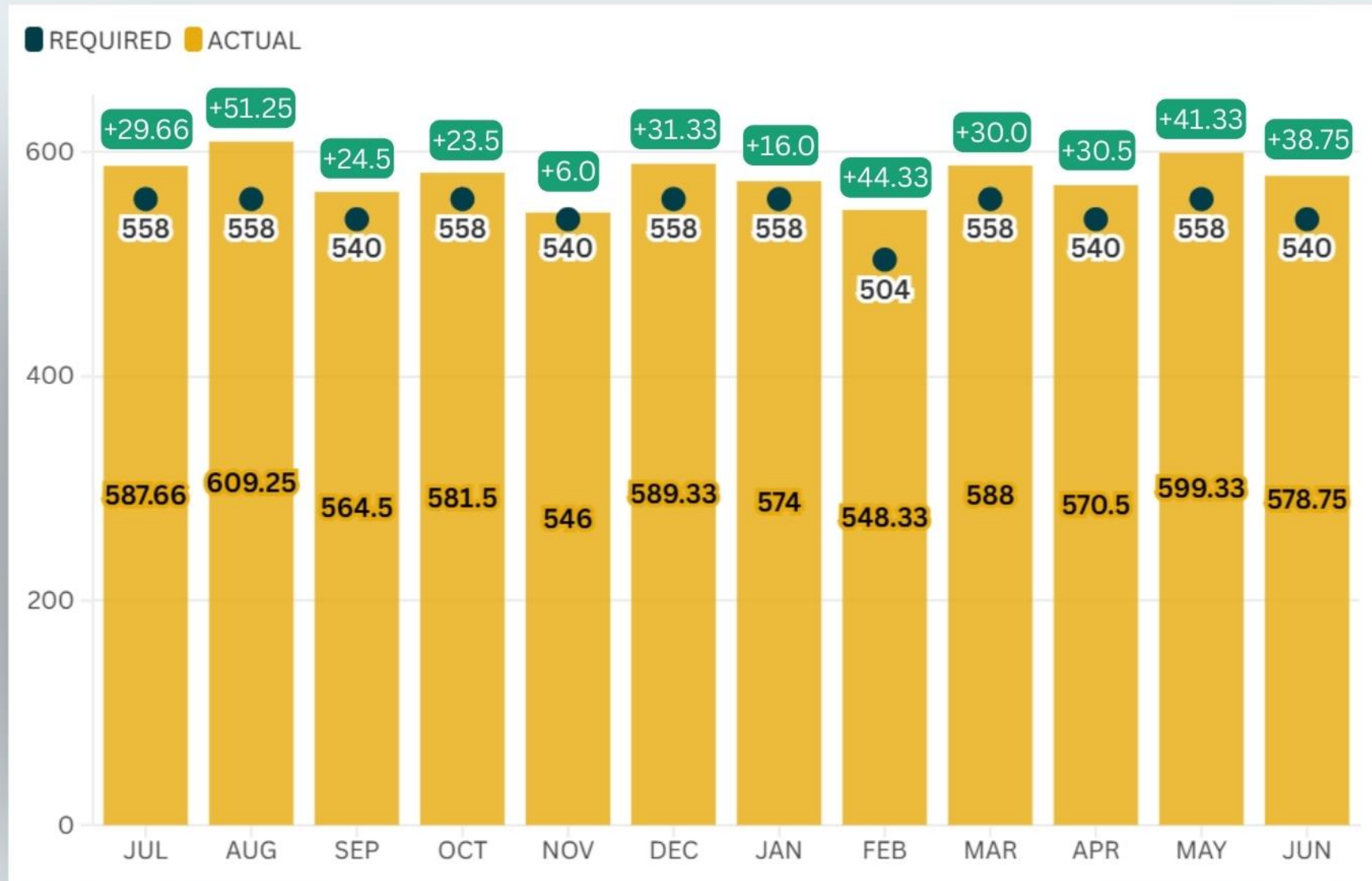

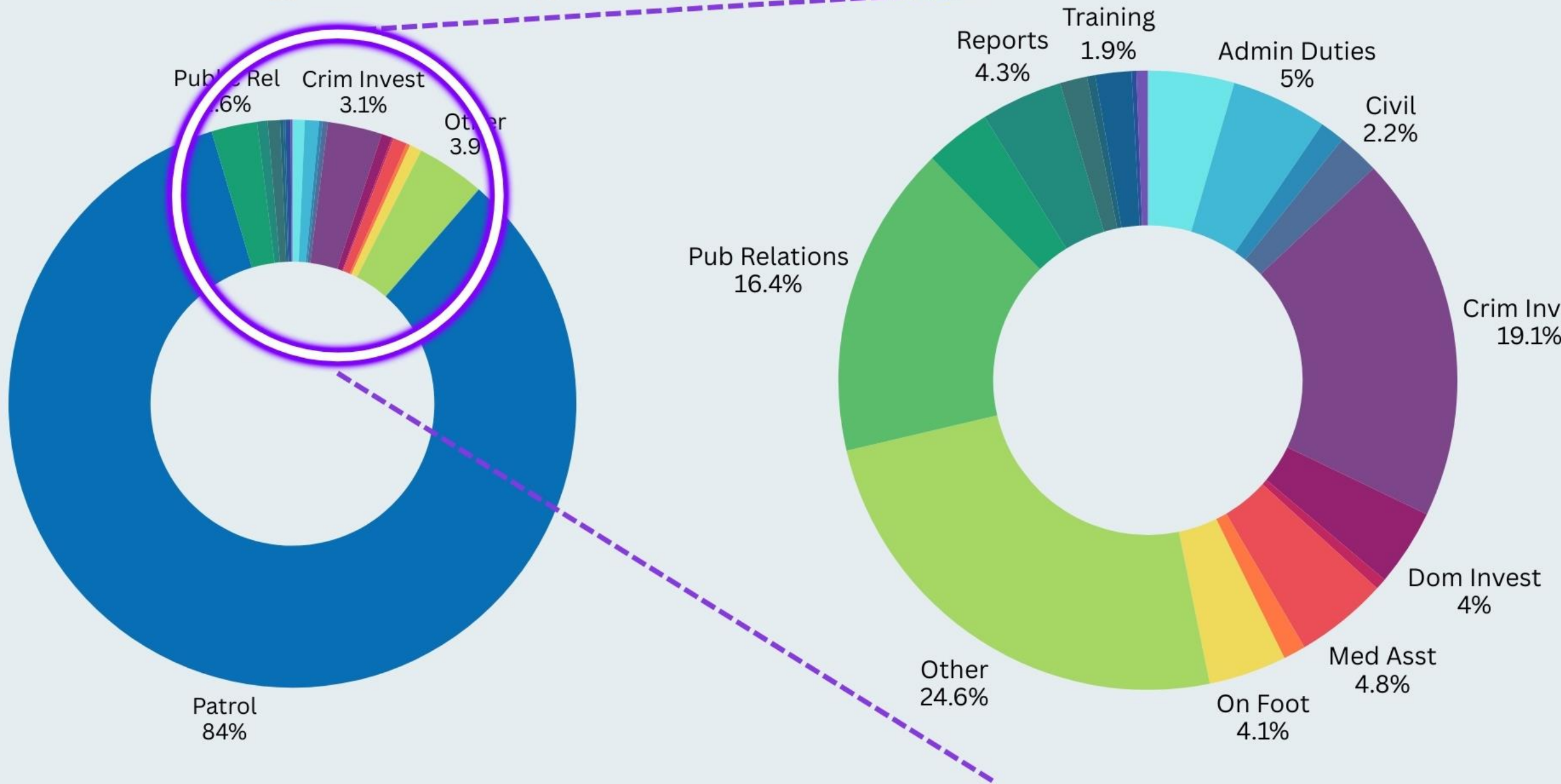
# Patrol Log Activity 24-25, **Hours Over/Under**



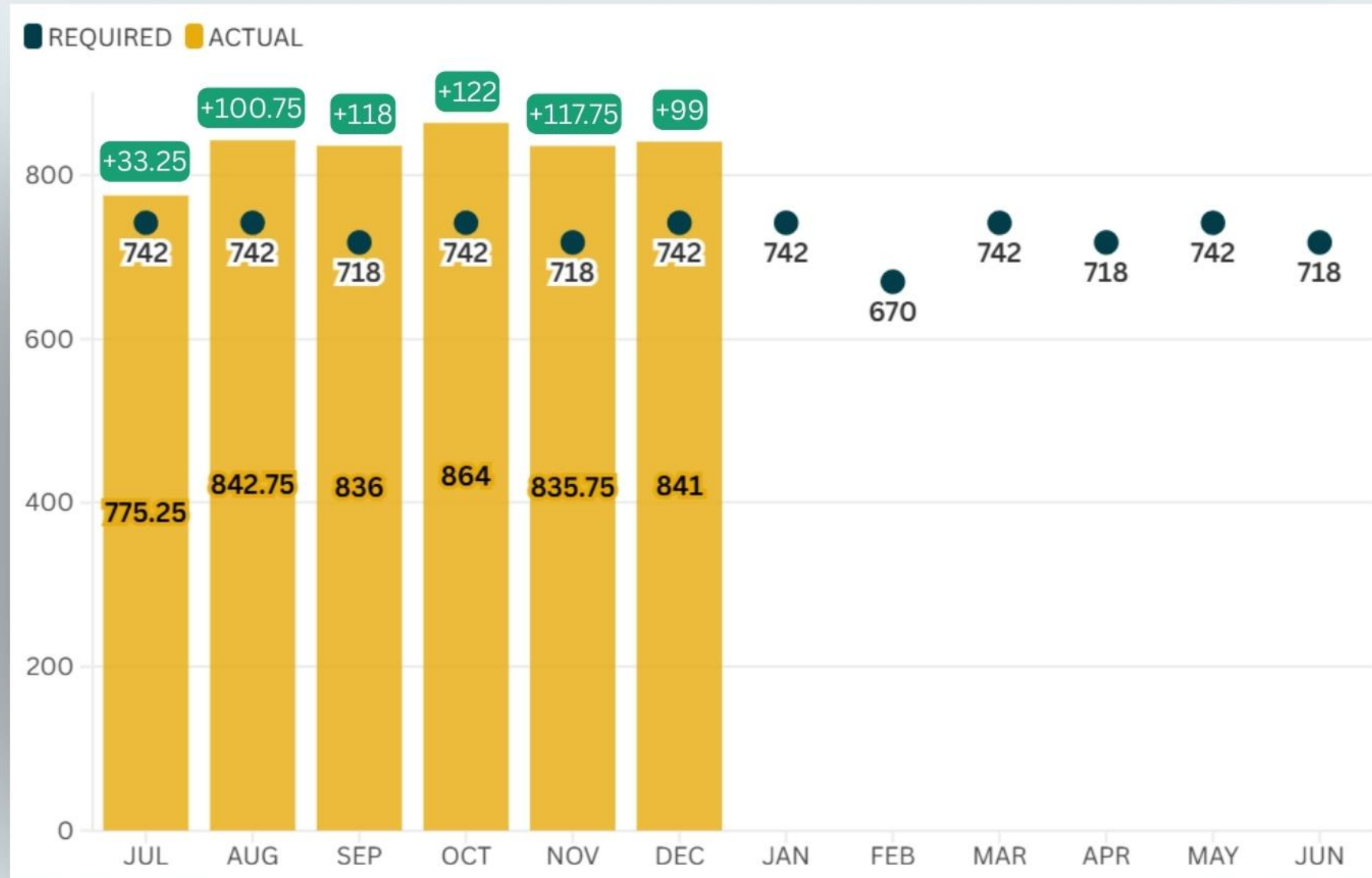

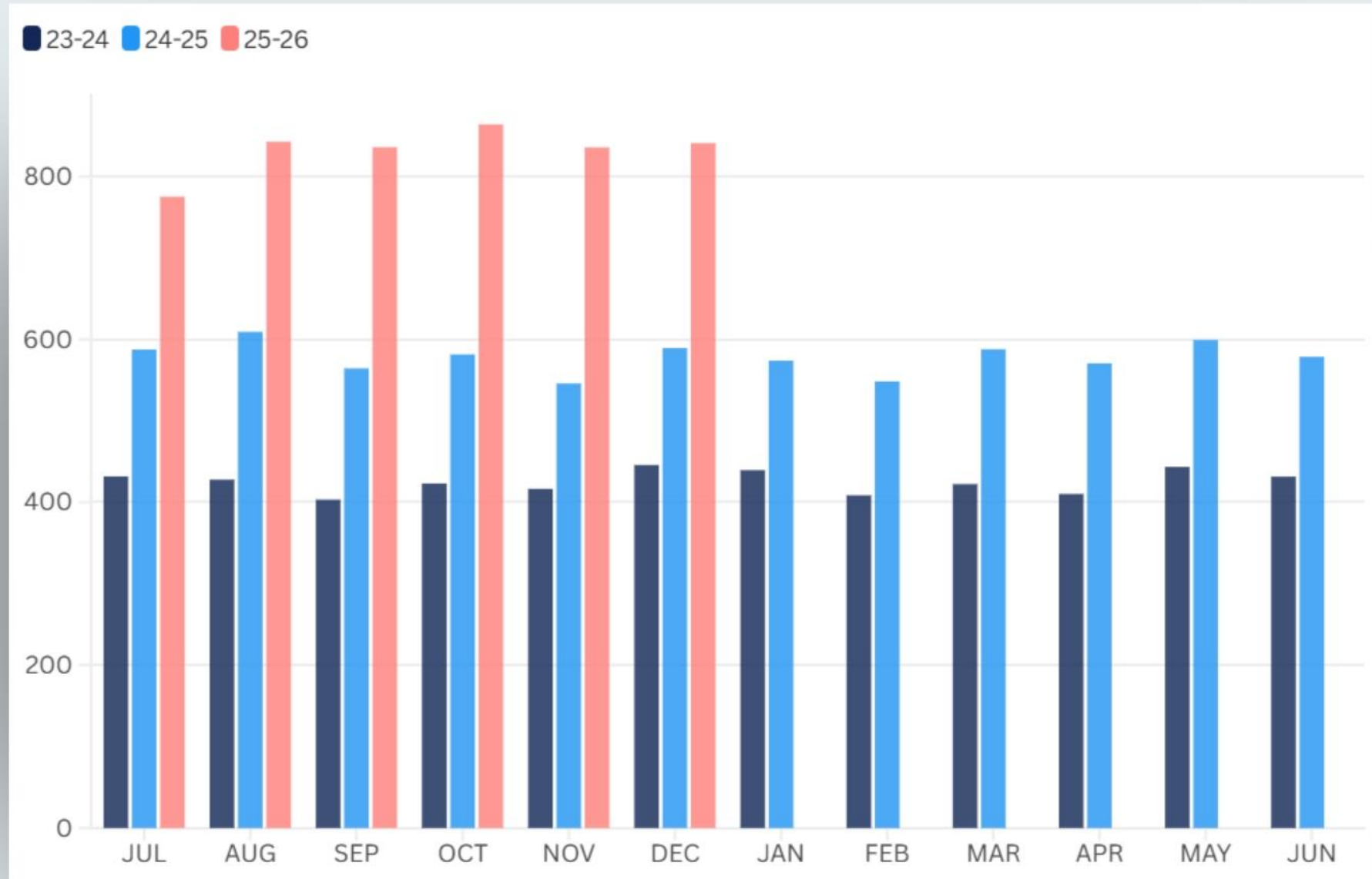

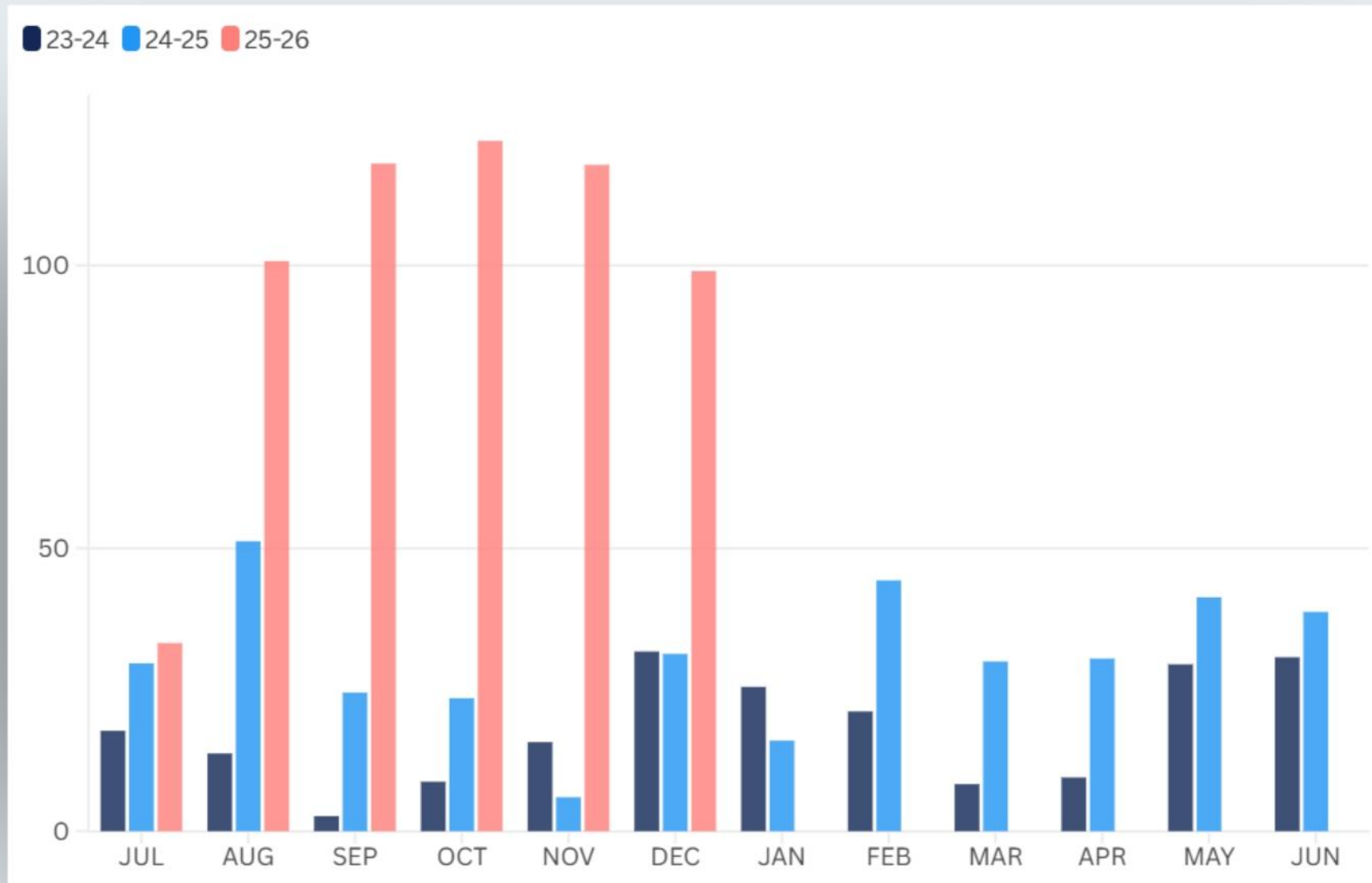

# Patrol Log **Activity** YoY Hours Logged



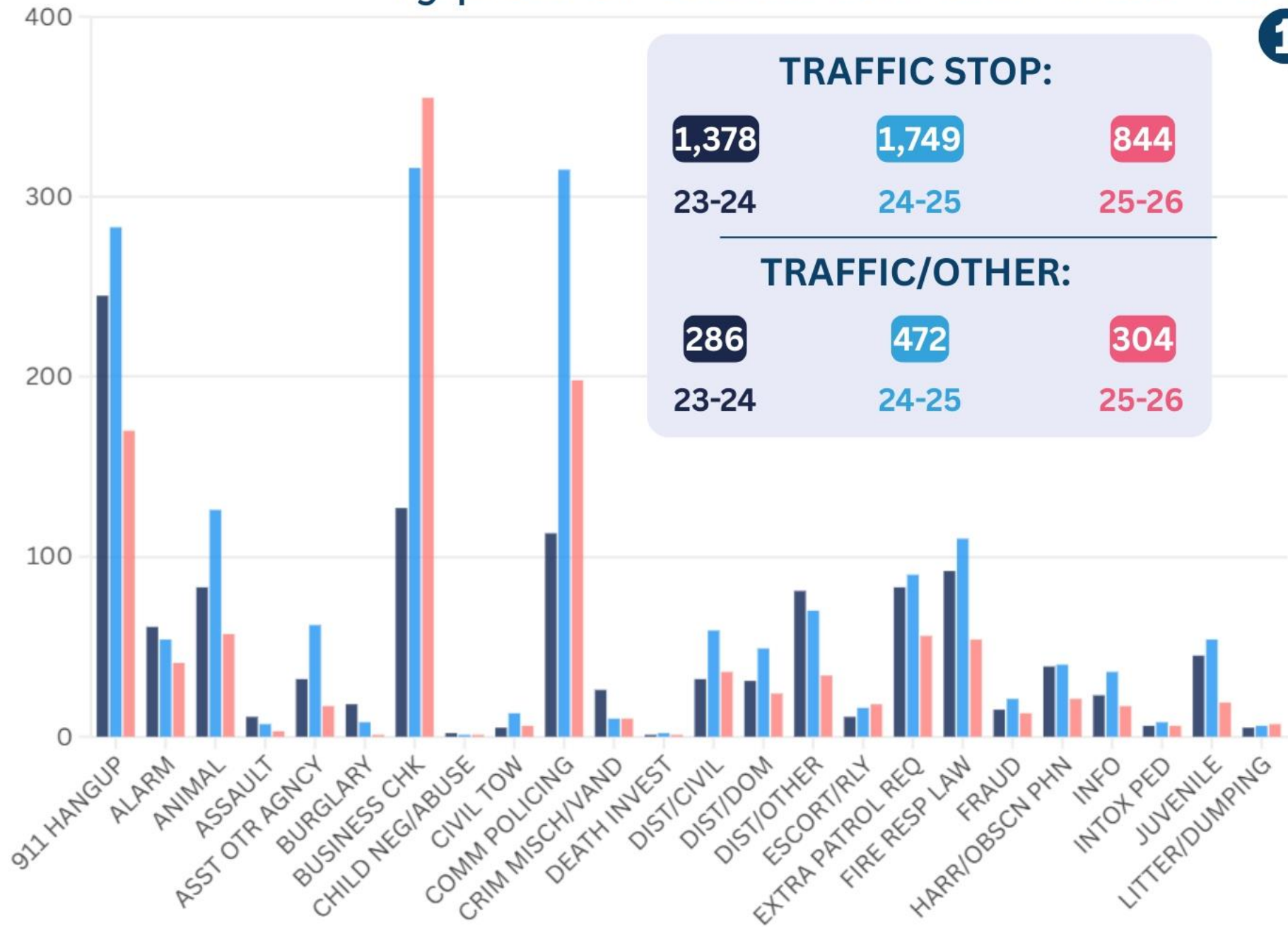

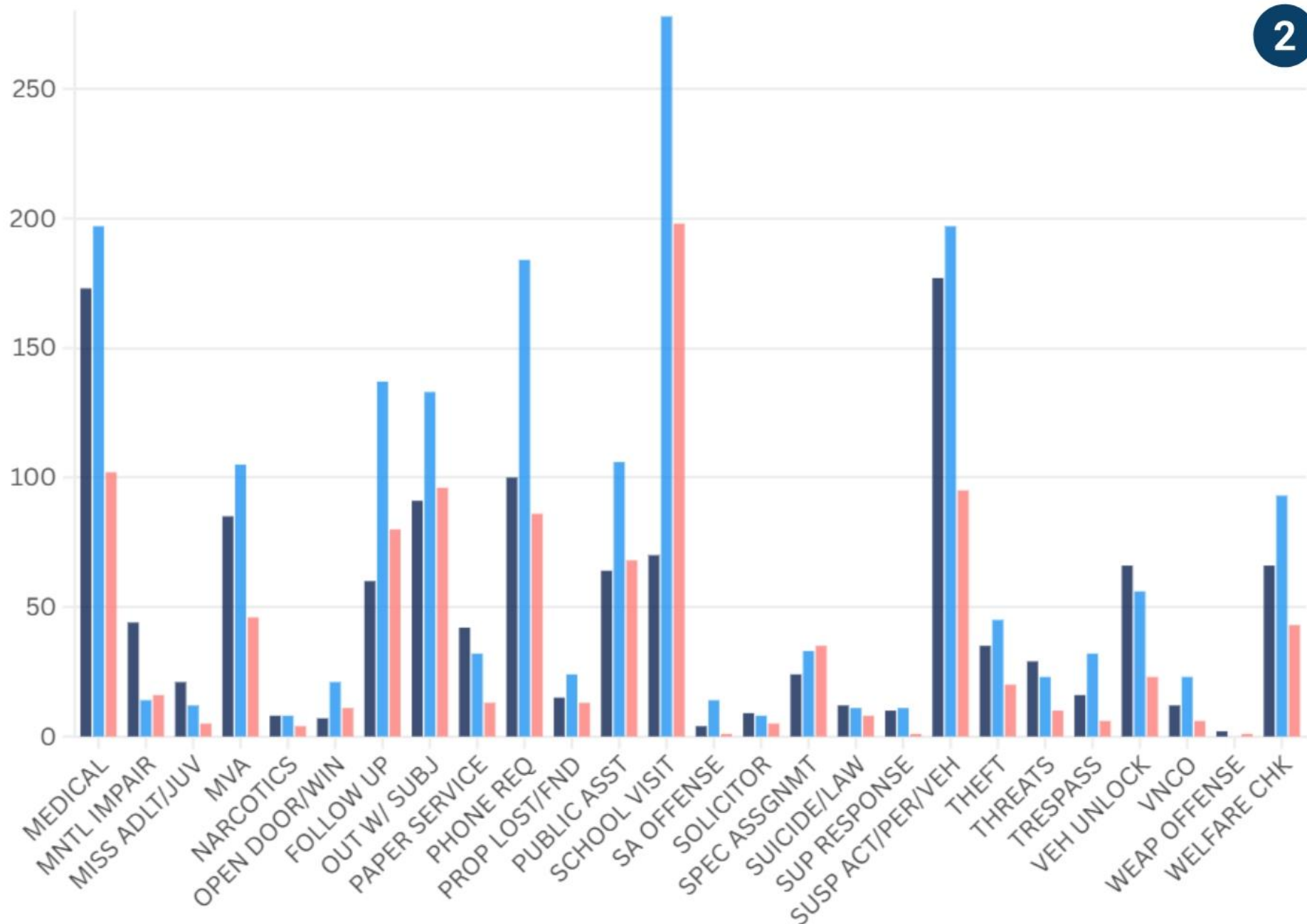

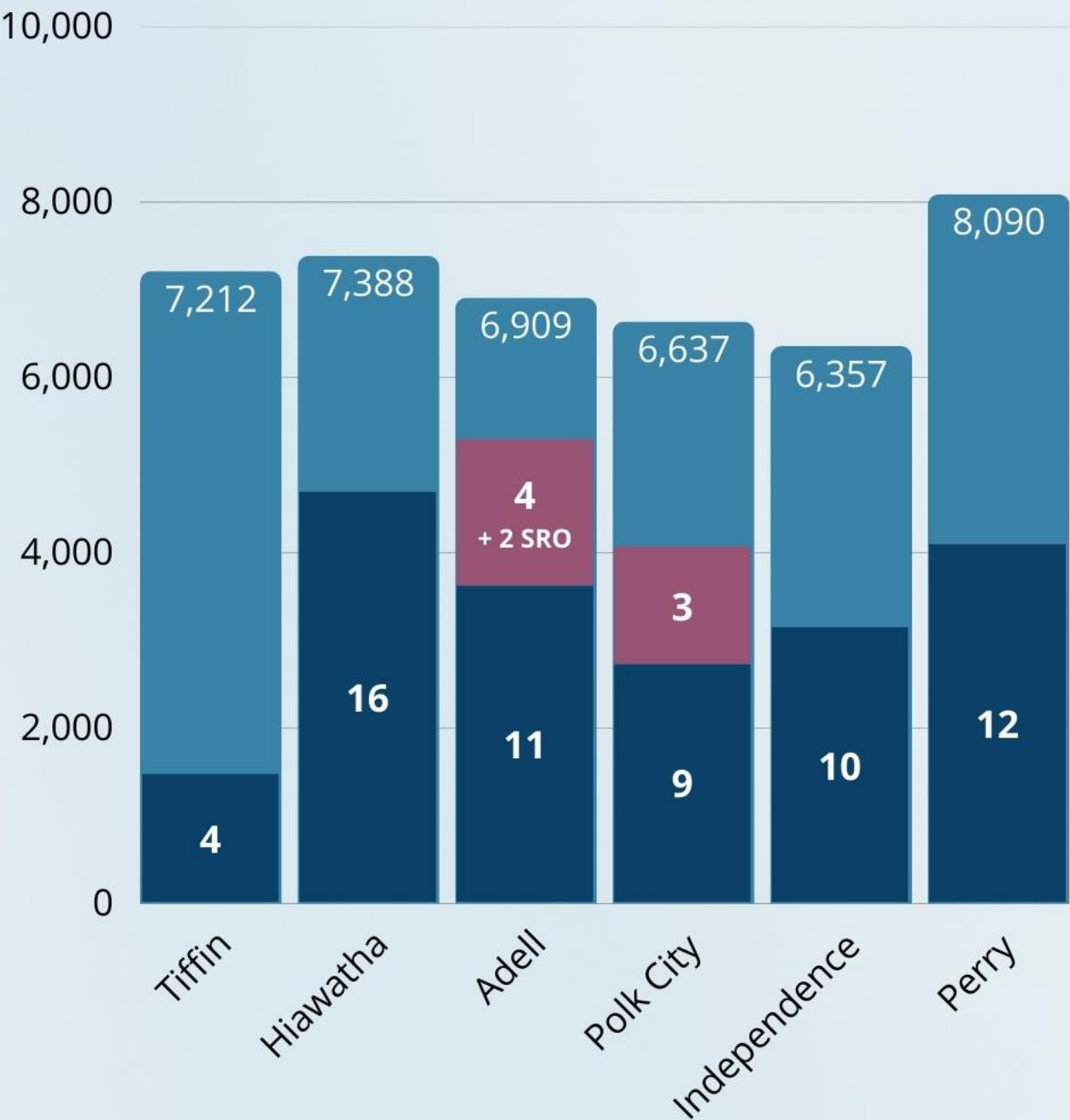
- As the amount of people increases, so will the number of incidents.

More demand on a few can lead to:

- Delayed results
- Overlooked problems
- Less or poor public interaction
