

**CITY OF TIFFIN
CITY ADMINISTRATOR
REPORT TO THE CITY COUNCIL
February 2, 2026**

- The City of North Liberty accepted the bid and authorized the execution of a contract with CJ Moyna & Sons, LLC, for the Forevergreen Road and Jasper Avenue Improvements Project (roundabout) at their January 20th City Council Meeting. CJ Moyna's bid was in the amount \$5,056,181.66. The engineer's estimate for the project was \$6,699,325.60.
- Ordinance No. 2026-523 – an Ordinance Rezoning the Grove Park Area is back on the agenda. With final plat documents not completed in time for the last council meeting, it has been requested to combine the second and third readings of the ordinance at the February 17th meeting.
- We are still planning for a special City Council meeting for the FY 2026-2027 budget. Please keep looking at your schedules for next week. We will confirm the meeting date at Tuesday's meeting.
- With no suggested changes to the draft of the results from the Minor Strategic Planning and Goal Setting session, the final draft will be on the next agenda for formal council approval.
- The Parks & Grounds Specialists position has been posted. The deadline for applications is Friday, February 27th.
