

RESOLUTION NO. 2026-043

A RESOLUTION DESIGNATING OFFICIAL PUBLIC POSTING LOCATIONS FOR MEETING NOTICES AND AGENDAS PURSUANT TO IOWA CODE CHAPTER 21, AS AMENDED BY HOUSE FILE 2490

Whereas, House File 2490 amended Iowa Code Chapter 21 regarding public notice requirements for meetings of governmental bodies; and

Whereas, Iowa Code Chapter 21 requires governmental bodies to designate official locations for the posting of meeting notices and agendas in addition to posting such notices on the governmental body's official website, if one exists; and

Whereas, the City Council of the City of Tiffin, Iowa, finds it to be in the best interest of the public to designate official posting locations that are readily accessible to residents.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Tiffin, Iowa, as follows:

A. Official Posting Locations. The following location is hereby designated as the City's official public posting locations for meeting notices and agendas:

1. Tiffin City Hall, 300 Railroad St, Tiffin, Iowa.

B. Website Posting. Meeting notices and agendas shall also be posted on the official website of the City of Tiffin (https://tiffin-iowa.org/city_government/index.php), as required by Iowa Code Chapter 21.

C. Amended Agendas. If a meeting agenda is amended after its initial posting, the amended agenda shall be clearly identified as an **"Amended Agenda,"** shall identify the item or items that were added, removed, or modified, and shall be promptly posted at the City's designated public posting locations and on the City's official website in accordance with Iowa Code Chapter 21.

D. Effective Date. This resolution shall take effect immediately upon its adoption and shall remain in effect until amended or repealed by resolution of the City Council.
