AGENDA ITEM:	Resolution 2026-008 – Setting a Public Hearing for an Ordinance Amending Chapter 56: Dog and Cat Licenses Required
ACTION:	Motion

Purpose

The purpose of this item is to request that the City Council approve Resolution 2026-008, which sets the date and time for a Public Hearing on the proposed ordinance amending Chapter 56: Dog and Cat Licenses Required of the Tiffin Municipal Code. The Public Hearing is proposed for March 3, 2026, at 7:00 p.m. at the Tiffin Fire Station.

Background

City staff have prepared updates to Chapter 56 of the Municipal Code to modernize Tiffin’s pet licensing program and transition to a rolling 365-day licensing system. This change removes the January 1–December 31 annual cycle, eliminates early-bird registration periods, and better aligns the City’s licensing practices with modern tools and administrative efficiencies. The full draft ordinance is included in the packet.

Iowa Code requires a public hearing before adopting an ordinance that amends the City Code. Resolution 2026-008 fulfills this requirement by formally setting the hearing date.

Proposed Ordinance Changes

The draft ordinance includes several key updates designed to streamline the program and support compliance:

- Establishes a 365-day license period beginning on the date of issuance, replacing the City’s current calendar-year system.
- Requires newly acquired, newly relocated, or newly eligible pets to be licensed within 30 days.
- Provides for temporary licenses for animals too young to receive vaccinations, with automatic conversion once rabies vaccination documentation is provided.
- Clarifies delinquency and delinquency fee procedures.
- Officially discontinues the calendar-year expiration and early-bird registration practices.

These changes improve administrative efficiency, simplify the licensing process for residents, and support the City’s transition to DocuPet’s modern pet licensing platform.

Recommendation

Staff recommends that the City Council approve Resolution 2026-008, setting the Public Hearing for March 3, 2026, at 7:00 p.m., to consider adoption of the ordinance amending Chapter 56: Dog and Cat Licenses Required.

CITY OF TIFFIN ORDINANCE NO. 2026-xxx

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF TIFFIN, IOWA, CHAPTER 56 DOG AND CAT LICECNSES REQUIRED

BE IT ENACTED by the City Council of the City of Tiffin, Iowa:

Section I. Purpose: The purpose of this ordinance is to update and modernize the City's animal licensing requirements by establishing a rolling 365-day licensing system, clarifying requirements for newly acquired animals, and discontinuing the January 1–December 31 license cycle and early-bird registration periods.

Section II. Amendment. Chapter 56 of the Tiffin Municipal Code is hereby amended by deleting the existing Sections 56.01, 56.03, and 56.04, and adopting the following in lieu thereof:

CHAPTER 56 DOG AND ACAT LICENSES REQUIRED

56.01 ANNUAL LICENSE REQUIRED.

1. LICENSE REQUIRED; TERM OF LICENSE. Every owner of a dog or cat over the age of six months (or of a dog or cat under six months no longer with its dam) shall obtain a pet license from the City. Licenses shall be valid for a period of 365 days from the date of issuance, and renewal shall be required annually based on the anniversary date of the initial license.

2. NEWLY ACQUIRED OR NEWLY ELIGIBLE ANIMALS. The owner of a dog or cat that reaches six months of age, is acquired by the owner, or is brought into the City shall obtain a license within 30 days of the animal becoming subject to this chapter. The license issued shall be valid for 365 days from the date of issuance.

3. TEMPORARY LICENSE FOR ANIMALS TOO YOUNG TO IMMUNIZE. If a dog or cat under six months of age is no longer with its dam and is too young to be immunized, a temporary license shall be issued upon payment of the regular fee. The temporary license shall expire seven months from the animal's date of birth, unless prior to expiration the owner provides a valid rabies vaccination certificate. Upon submission of such certificate before the animal reaches seven months of age, the temporary license shall automatically convert to a regular annual license valid for 365 days from the date of conversion.

56.03 DELINQUENCY.

1. DELINQUENCY DEFINED. A license shall be considered delinquent if not renewed by the expiration date printed on the license tag or listed in the City's licensing system.

2. DELINQUENCY FEES. Delinquent fees, as established by resolution of the City Council, shall be assessed in addition to the annual license fee. Delinquent fees shall not apply in cases where, due to age, new ownership, or prior residency outside City limits, the animal was not subject to licensing before the license expiration date.

56.04 EXPIRATION. All pet licenses issued by the City shall expire 365 days from the date of issuance, regardless of when the license was obtained. The City shall no longer operate on a January 1–December 31 licensing cycle, and early-bird registration periods are discontinued.

Section III. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section IV. Severability Clause. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section V. When Effective. This ordinance shall be in effect July 1, 2026.
