Quarterly Report to the Warren County Commission For the Commission Meeting Monday, December 16th, 2024 (Prepared 12/6/24)

Dear County Commissioners,

Total sales in the last quarter were 12.6% over the previous quarter, and contribution was up 9.2%. This was due partly to an increase in avgas fuel sales by MTSU training aircraft. MTSU's fuel supplier is having trouble getting them fuel, and MTSU is purchasing quite a bit here in the meantime. Jet fuel sales were up from the last quarter but down from a year ago. Of the thirty-seven surrounding general aviation airports, we usually rank around the eighth lowest in both avgas and jet fuel. Activity and sales usually decline during the next three winter months. I have attached our usual operating reports.

Your Airport Commission has finalized the design of a pole barn maintenance building for our tractors and other groundskeeping equipment. Once we occupy the building, we will free up two t-hangars for rental. We expect to publish a request for bids in the next few weeks with the goal of completing the building by May.

Last quarter the airport saw a good deal of community involvement with the airport. In October five of our local pilots made seventeen flights carrying Hurricane Helene relief supplies to airports in East Tennessee and western North Carolina. On November 16^{th,} the local EAA chapter held their last fly-in breakfast of the season. Over fifty planes flew to our airport, and the chapter served approximately 175 meals. And on that same Saturday in November, EAA volunteer pilots took twenty kids between the ages of 7 to 17 up for their first ride in a small aircraft. The fly-in breakfasts will resume next March and continue to be on the third Saturday of the month through next fall. And again, on election day, our airport terminal building served as a polling place.




